- 1. Established a quorum of board members
- 2. Eddie G. made a motion to accept the 2021 Annual Meeting minutes; Joseph Jeffers second(ed) motion; Motion was unanimously approved.
- 3. Officer's Report
 - a. Saul's Ranch sold; Milestone purchased; HOA commented at public forum with concerns on how they are routing streets and making Oak Creek streets major thoroughfares for new neighborhood
- 4. Renovation Report
 - a. Bidding and bid "scrubbing" process is complete, lowest bid/Fazzone Construction selected, and we anticipate starting renovations soon
- 5. Social Committee
 - a. Summer 2022 pool party was a success
 - b. We anticipate having an Easter egg hunt in April
- 6. Elections
 - a. During this meeting there are two Board Member positions up for election. Eddie Greene seeks re-election and there is 1 additional Board position on the Ballot. Eddie asked if there were any floor nominations. There were none.

- 7. Treasurer's Report
 - a. Total checking and reserves are over \$642,000; YTD Financials are currently at a loss of under \$14k, but noted that operating account is reduced by transfer to reserves by \$1961/month
 - b. Expenses for year have exceeded budget, but not significantly; HOA HO fees and interest income are slightly down contributing to loss.
 - c. Overall HOA is in good financial shape to cover clubhouse renovation contract
 - d. It's anticipated that we want to increase dues by 5%
- 8. Homeowner Feedback/Discussion
 - a. Karen Marquardt Can ACC approval process be streamlined? **Response: Eddie is working with ACC** committee to get something in writing; conversations are happening
 - b. Mr. Villarreal When is the garage sale in the neighborhood? **Response: Goal is to coordinate with Oaklands when they have theirs.**
 - c. Mark Pierce How many rentals are in the neighborhood? Do we have a rental max? Can we have a rental max? Response: Don't have an exact number, probably around 10%. We don't have a rule or cap on the max rentals. Will ask Connie to see what it would take to change this rule. It would likely take ²/₃ HO signatures to add this rule.
