**<u>Rules.</u>** The undersigned agrees to abide by the Oak Creek Homeowners Association rules and policies for the Clubhouse, attached as **Exhibit A**. It is understood that a Member of the Board of Directors of the Oak Creek Homeowners Association, Inc., or a person designated by the Board, may inspect the Clubhouse including furniture, window coverings, equipment and the area surrounding the Clubhouse, before and after use by the undersigned. Any items not in good condition will be repaired or replaced as necessary. The undersigned agrees to pay for any repairs or replacement, and if it is not promptly paid, the Oak Creek Homeowners Association, Inc. shall have a lien against the unit owned by owner for payment of same, which lien may be collected in same manner as monthly assessments.

**Texas host/liquor laws.** The undersigned understands that under Texas law, a host of any social event or business function where alcoholic beverages are served may be personally liable for any property damage, personal injuries, or loss of life resulting in whole or in part from the host's

negligence in allowing any intoxicated guest or attendee to be served alcohol. Such liability may include harm to the intoxicated individual himself and also harm to total strangers involved in automobile accidents, etc. caused by that intoxicated individual.

<u>Hold Harmless and Indemnification</u>. The undersigned hereby releases and shall hold harmless and indemnify the Oak Creek Homeowners Association property owners and the employees, contractors, agents, affiliates, and related entities thereof for all claims, attorney's fees, and other costs or liabilities incurred by or asserted against any of the foregoing as a result of use of the Oak Creek Clubhouse by owner or owner's tenants or guests.

<u>Condition of Clubhouse before and after</u>. The undersigned agrees to inspect the Clubhouse prior to acceptance and to show the condition in the "Check-In Condition" attached as Exhibit C to this agreement. Oak Creek Homeowners Association, Inc

# Exhibit A - Rules for the use of the Oak Creek Clubhouse by Owners or Tenants

1. <u>Fee.</u> An Oak Creek owner renting the Oak Creek Clubhouse (the "Clubhouse") will sign a rental agreement and release prior to renting the Clubhouse. If a tenant in Oak Creek leases the Clubhouse, the owner and the tenant must both sign the required rental agreement and release. The rental fee is payable in advance. The rental fee is **\$50.00 for 4 hours** (minimum of 4 hours rental plus \$10.00 each additional hour after 4 hours)

2. <u>Late usage</u>. In addition to the rental fee, a \$25.00 fee may be assessed to the renting homeowner if the clubhouse is not vacated by the end of the time block.

3. <u>MINIMUM Cleaning fee</u>. In addition to the rental fee, these fees may be additional cost if clubhouse is not returned to original state including a \$50 service call: Floors not swept - \$15, Refrigerator dirty or items left behind - \$20, Holes or tape on walls, windows, railings, doors, etc. - \$45, Trash/debris - \$35, Crumbs or sticky debris left on tables, chairs, floor, etc. - \$25

4. <u>Alcoholic beverages</u>. Alcoholic beverages may not be served to minors or intoxicated persons at the Common Area. Under Texas law, a host of any social event or business function where alcoholic beverages are served may be personally liable for any property damage, personal injuries, or loss of life resulting in whole or in part from the host's negligence in allowing any intoxicated guest or attendee to be served alcohol. Such liability may include harm to the intoxicated individual himself and also harm to total strangers involved in automobile accidents, etc. caused by that intoxicated individual.

5. **<u>Smoking</u>**. No smoking is permitted within the clubhouse at any time.

6. **Decorations.** No tape, tacks, push pins, or staples may be used or placed on walls or ceilings of the clubhouse and no pictures or decorations may be hung within the facility in such a way that it causes damage to the walls or ceilings. Nothing is to be attached to the ceiling fans.

7. <u>Assessments current</u>. The Clubhouse is not available for rental to any owner if the Oak Creek owner assessments and other sums due the Association by the owner are not current.

8. <u>Owner as host</u>. Only (1) owners, (2) tenants may reserve the Clubhouse. The Oak Creek owner or tenant must be present at all times at the function for which the Clubhouse is rented and must be the primary host of the event. Owners or tenants may not reserve the area on behalf of a third party. No activity or event for which the clubhouse is rented may be advertised or publicized in any manner to solicit the attendance of the general public. No admission may be charged at the door.

9. <u>Pool</u>. The pool area may not be rented. It is for the use and enjoyment of all owners and guests and has its own hours of operation and will be available for the use of other tenants and owners at all times.

10. <u>Music</u>. Music, and/or any other noise, must be kept at a level that it cannot be heard in the surrounding homes in the area. The renter of the clubhouse will be responsible for seeing that there are no loud noises from the guests either coming to or leaving the function at the clubhouse.

11. <u>Clean up of Clubhouse</u>. The Oak Creek homeowner who rents the clubhouse will be fully responsible for cleaning the clubhouse and any other area used, including all equipment and furniture, immediately after the function ends. The disposal of all trash and garbage from the clubhouse premises. (Including deck, playscape, landscaping and parking lot) If onsite trash cans are full then all remaining trash must be taken HOME with renter to properly dispose. NO TRASH BAGS ALLOWED LEFT BEHIND.

12. <u>Damage</u>. The Oak Creek homeowner will be responsible for the repair or replacement of any damage done to the Clubhouse, or its furniture, equipment, or window coverings.

13. <u>Assumption of risk</u>. The Oak Creek owner will assume full responsibility for any and all accidents or claims that may arise as a result of any accident or for any other reason in connection with the function or lease of the Clubhouse by the owner and said owner shall agree to the hold harmless and indemnity provisions contained in the Rental Agreement to which these rules are attached.

14. <u>Heat/AC</u>. Heat and/or air conditioning must be returned to **90** (summer) or **45** (winter) and lights are to be turned off when the function is over.

15. Lock doors. The Oak Creek owner or tenant will lock the doors when the function is over.

16. City codes. All applicable city and fire codes apply.

17. Occupancy limit. No more guests than the fire code permits are allowed at any function.

18. No lifeguard at pool. Use of the pool is at owner and guest risk.

#### NO LIFEGUARDS ARE PROVIDED BY OAK CREEK - DO NOT PROP GATE OPEN!

19. <u>Violation</u>. Violations of these rules will be determined by the Board in their sole discretion. Violations will subject the owner to any corrective or enforcement action authorized by the Association's governing documents or by law, and penalties may include without limitation the loss of use rights for the Clubhouse for one year.

20. Hours. All functions must end by 10:00 p.m. on weeknights and by 12:00 a.m. on Friday or Saturday nights.

The undersigned is responsible for all persons who attend the event for which the clubhouse is rented. The breach or violation of any condition set forth herein may result in fines/fees and the denial of future use of the clubhouse.

# Exhibit B - Oak Creek Homeowner's Association Pool Rules

# No lifeguard on duty. Swim at your own risk!

1. Pool hours: 6:00 a.m. to 10:00 p.m. Sun. – Thurs., and 6:00 a.m. to midnight Fri. and Sat. Lap swimming 5:00 a.m. to midnight every day.

- 2. Children under 12 years of age must be attended by an adult 18 years of age or older.
- 3. Swimmers must be members, or guests of members, of the Oak Creek Homeowner's Association.
- 4. No bicycles, roller blades, scooters, or skateboards in the pool area.
- 5. No diving. No running in the pool area.
- 6. No glass containers in the pool area.
- 7. No cutoffs or street clothes in the pool.
- 8. No food or drinks allowed in the pool.
- 9. No pets allowed in the pool area.
- 10. Volume on radios must be kept to a reasonable level.
- 11. Swim diapers must be worn by children as necessary.
- 12. Litter should be placed in designated containers.
- 13. Lap lanes are reserved for lap swimmers at all times.
- 14. No public intoxication within the common area.
- 15. Repeated violations may result in revocation of pool privileges.

#### Check-in condition

### Clubhouse Cleanup Checklist

To avoid any additional fees all of the following must be completed:

### Clubhouse:

- 1. Stack all chairs and place to original location.
- 2. Wipe down ALL tables, chairs, and counters.
- 3. Remove all items from Refrigerator.
- 4. Clean/sweep clubhouse floor of any trash, stains or spills.
- 5. Pickup/Remove ALL trash and dispose at HOME.
- 6. Place all items back in original location
- 7. All lights and ceiling fans must be turned off
- 8. Remove ALL decorations including tape or adhesives used.
- 9. Reset HVAC to 90 degrees (summer) or 45 degrees (winter) before leaving.
- 10. Lock all doors, confirm that back double doors are properly secure and locked.

### Pool and Playground:

- 1. Reset tables and chairs to original location.
- 2. Wipe down ALL picnic tables, pool tables, and chairs.
- 3. Clean/sweep pool deck of any trash or spills.
- 4. Clean BBQ grills is used.
- 5. Pickup/Remove ALL trash and dispose at HOME.
- 6. Remove ALL decorations including tape or adhesives used.

The undersigned is responsible for all persons who attend the event for which the clubhouse is rented. The breach or violation of any condition set forth herein may result in fines/fees and the denial of future use of the clubhouse.
